For the Archdiocese of Chicago Parishes, Schools and Agencies.

Complete and send the Stock Donation Letter of Intention.

ALL STOCK DONATIONS MUST ACCOMPANY a stock donation letter of intention. The Letter of Intention may be attached to these instructions. If not it is available via:

STOCK CERTIFICATE/S DONATION:

Transfer The Stock/Securities

You can transfer securities three (3) ways: Electronically, by Registered mail, or Hand deliver in person.

1. **ELECTRONICALLY** - To transfer the securities electronically:

Reminder: Fax, E-mail or Mail the completed Letter of Intention to parish Operations-stock donation at the Archdiocese of Chicago. (Address is listed above)

2. **REGISTERED MAIL** - To transfer the stock certificate by Registered Mail:
 - Stock certificate(s) in the name of the parish, school, or agency can be sent to us without a signature or irrevocable stock bond power. Place the Stock Certificate(s) and the stock donation Letter of Intention in an envelope and send via **REGISTERED MAIL**.
 - Stock certificate(s) in the Donor's name – **DO NOT SIGN** the stock certificate(s). Send the Stock Certificate(s) to us in one envelope via Registered Mail. In a separate envelope send a completed, signed and dated irrevocable stock bond power form, together with the completed stock donation Letter of Intention. Via Registered Mail. (2 separate envelopes – via Registered Mail) to: Archdiocese of Chicago – Parish Operations – Stock Donations - 835 N. Rush St., Chicago, IL 60611.
 - An irrevocable stock bond power form is available on our website: www.archchicago.org Click on Departments – then Finance – scroll down to Parish Operations Documents – click on irrevocable stock bond power form. Or call us at 312/534-5399 – we can fax or e-mail the form to you.

3. **HAND DELIVER** - to deliver the securities (stock certificate) in person:
 - **DO NOT SIGN** the stock certificate(s).
 - Contact Parish Operations – Stock Transfer Representative at 312/534-5399 to arrange a time to deliver the stock certificate(s), irrevocable stock bond power and stock donation Letter of Intention.

Please note: Stock Certificates received stamped “RESTRICTED” will experience longer processing times.

MUTUAL FUND DONATIONS

ALL mutual fund donations –
Due to various methods of transactions required to obtain funds from mutual fund accounts - Parish Operations recommends the Parish, School, Agency or Donor to contact Parish Operations Stock Donation Representative at 312/534-5399.

Parish Operations will obtain all information as required and process the transaction accordingly.

Please Note: Mutual fund donations experience longer processing times. Please keep this in mind when donating at the end of the Calendar year.
